1. Background

The RisiAlbania Project is supported by the Swiss Agency for Development and Cooperation (SDC), in partnership with Ministry of Finance and Economy and implemented by a consortium consisting of HELVETAS Swiss Intercooperation and Partners Albania. The overall goal of the project is to contribute to an increase in employment opportunities for young women and men (age 15-29) in Albania. This goal will be achieved through:

- (i) enhanced growth and job creation by the private sector in three selected subsectors agro business, tourism, and ICT (labor demand),
- (ii) improved access to job opportunities and labor market information and services (intermediation), and

(iii) improved skills of young people by improving the offer of private training providers in the three selected sectors (labor supply).

Risi is supporting the General Directorate of Accreditation (DPA) to extend its accreditation capacities to provide accreditation against ISO 27701 in order to respond to market needs. The extension of DPA capacities involves the development and adoption of accreditation rules and related processes.

2. Objective(s) of the consultancy

The objective of consultancy is to build capacities at DPA to provide accreditation services related to ISO 27701 and eventual recognition of ISO 27017 and 27018 as integrated guidelines with the standard ISO 27001.

3. Expected Outputs

Based on the existing documented management system structure for ISO 27006 accreditation, the consultant is expected to:

- Deliver a training to DPA decision makers and file manager on ISO 27001; ISO 27006:2015; Amd 1:2020; and ISO 27005.
- Deliver a refresh-training to DPA lead assessors, technical assessors and technical experts on ISO 27001 and new requirements of ISO 27006:2015 Amd 1:2020 and ISO 27005.
- Develop the rules and process for accreditation of ISO 27701 certification scheme and:

- Develop additional instructions for accreditation according to ISO 27701.
- Define the competence criteria for ISO 27701 assessors and decision makers, taking into consideration the requirements established in IAF MD 13.
- Deliver a training to DPA lead assessors, technical assessors and technical experts on ISO 27701 and training of DPA decision makers and file managers.
- Develop guidelines for the application of ISO 27017 and ISO 27018 as integrated standards with ISO 27001.
- Deliver a training to DPA lead assessors, technical assessors and technical experts on ISO 27017 and ISO 27018 and training of DPA decision makers and file managers.

4. Deliverables

The Consultant/s will write an activity report including the above-listed documentation by March 25th 2022.

5. Consultancy profile

RisiAlbania and DPA are looking for a National Accreditation Body (NAB) or Consultant who bring:

- At least 3 years' experience as part of a NAB in positions such as lead assessor or technical assessor for ISO 27001 and knowledge about add-ons (ISO 27701, and guidelines ISO 27017 and ISO 27018).
- The NAB must be signatory member of EA-MLA or IAF MLA for management system certification for sub-scope ISO 27001.
- Previous experience in training activities in international information security management system standards.
- Fluency in written and spoken in English.

6. Management and Reporting

The selected consultant will report to the RisiAlbania ICT Senior Intervention Manager. Deliverables will be approved by DPA.

- b. **Financial proposal** (free format): the proposed daily fee for each expert shall include all taxes. The financial proposal must include separate budget lines for activities undertaken by each proposed expert as well as an expected level of effort for each expert.
- c. **CV**: latest CV of service provider(s) (up to 3 pages), documentation of relevant previous experience (if possible), and contacts of the respective references.
